On 1 January 2020, the revised ECI Regulation (Regulation (EU) 2019/788 on the European citizens' initiative) started to apply.

Since then, various positive developments indicate that the revised rules provide a more accessible, less burdensome and more user-friendly framework for ECI organisers and supporters.



HOW TO START A EUROPEAN CITIZENS INITIATIVE?



Preparation

A group of organisers is set up to run the ECI, including minimum 7 EU citizens residing in 7 different Member States

Registration

The Commission assesses if the conditions for registration are fulfilled

Collection

The organisers have 12 months to gather the support needed to reach the required thresholds


Verification

Verification of statements of support by competent national authorities

Examination

Meeting with the Commission, public hearing in the European Parliament and final response of the Commission

How does the EU support organisers?



A **Central Online Collection System** is available in all EU languages free of charge. The high level of security of the collection system ensures that personal data are encrypted and safely handled throughout the process.



The **ECI Forum** is a support service which offers free legal advice and practical guidance to organisers during all the steps of the ECI process.



The Commission is organising a wide range of multilingual communication activities to inform and engage citizens with the ECI. 64% of EU citizens are aware of the ECI according to the latest Eurobarometer results.

HOW TO SUPPORT AN INITIATIVE?

To support an ECI, **EU citizens must be old enough to vote in European Parliament elections.** The revised ECI Regulation allows Member States to lower the age to support ECIs to 16. As such, in most EU countries the support age for ECIs is 18, while it is under 18 in 6 EU countries: 17 in Greece and 16 in Belgium, Germany, Estonia, Malta and Austria.

Citizens can sign initiatives on paper or online.

Member States have to ensure that their citizens can **support initiatives online using electronic identification means or an electronic signature.** This is ensured in 16 Member States (Bulgaria, Czechia, Denmark, Ireland, Spain, France, Croatia, Italy, Cyprus, Latvia, Lithuania, Luxembourg, Hungary, Netherlands, Poland, Portugal, Romania, Slovenia, Slovakia, Finland, Sweden) and is in the process of being implemented in Bulgaria, Denmark, France, Poland and Slovenia.
