Initiatives status since last Expert Group

- 7 new initiatives started using the E.C. Central Online Collection System
 - Preservation and development of Ukrainian culture, education, language, and traditions in EU states
 - Creation of a European Environment Authority
 - Trust and Freedom
 - Effective implementation of the concept of judicial precedent in EU countries
 - Taxing great wealth to finance the ecological and social transition
 - End The Horse Slaughter Age
 - Article 4: Stop torture and inhuman treatment at Europe's borders



Submission to Member States for validation


Member States validated successfully the supports of "Fur Free Europe".

IT process went smoothly.

All Member States uploaded their Annex VI in the File Exchange Service.



Citizens' satisfaction rate about COCS



560.000 feedbacks collected from citizens having supported initiatives using the Central Collection System since 2020

Same % as 8 months before with 30.000 feedbacks additionally collected


Integration with EU login


Supports using eIDs vs total number of supports

- In the context of the periodic review of the ECI Regulation, an external IT research team analysed the possibilities for embeddable solutions for the central online collection system that the Commission could offer to ECI organisers.

- Action 1: enhancing ECI awareness and visibility
- Action 2: strengthening support for ECI organisers
- Action 3: continued improvement of the central online collection system
- Action 4: strengthening ECI implementation at national level and in cooperation with civil society
- Action 5: a more visible follow-up of ECIs



Action 3: continued improvement of the central online collection system

- Usability and accessibility study project kicked off by the European Commission in Q1 2024.
- Conclusions expected by Q2 2024.
- Implementation will start in H2 2024.
